JUDGES NOMINATION FORM

The LEN European Championships Aquatics - Open Water Swimming Championships will be held in Budapest (HUN) from 20 to 24 May 2020.

Each LEN affiliated member Federation is entitled to make nominations for a maximum of three Open Water Swimming Officials. Nominated Officials must be on the **FINA Referees List (12 or 13)**.

According to the LEN Rule:

“EURO 6.5.2 Federations may nominate up to three (3) judges qualified on the current LEN and/or FINA List(s). Nominations shall be submitted to the LEN Office no later than the date announced by the LEN Office. Officials approved by the LEN TOWSC are on the costs of the nominating Federation EURO 6.5.3 The Organising Federation shall supply all other officials.”

The list of nominees will be tabled to the LEN Technical Open Water Swimming Committee for final selection and approval. The approved list will be circulated mid-March 2020.

PLEASE NOTE THAT A MAXIMUM OF OFFICIALS WILL BE SELECTED FOR THE EVENT, DEPENDING ON THE NUMBER OF NOMINATIONS RECEIVED.

In submitting this Nomination form the member Federation confirms and accepts the following conditions of appointment and acceptance:

1. All travel and accommodation costs will be the responsibility of the member Federation.
2. All appointed officials agree to stay at the designated LEN officials' hotel, the Aquincum Hotel. The prices per person per night:
Single room with full board (3 course menu): 210 EUR / per night
Single room with full board (buffet style): 230 EUR / per night
Double/twin room with full board (3 course menu): 275 EUR / per night
Double/twin room with full board (buffet style): 315 EUR / per night

3. Appointed officials must have a reasonable knowledge of English (speaking and writing).
4. In the event that a nominated official is not able to attend, LEN reserves the right to impose a fine of €150 for non-attendance in accordance with LEN Rules.
